# Adopted downtown plan recommends preservation of Main Street District


#### Renaissance of special character

Preservation Alliance has long promoted the value of the Main Street Historic District to the overall revitalization goals of downtown Owensboro. And now the Owensboro City Commission has formally endorsed preservation of the district by adopting the **Downtown Owensboro Action Plan** prepared by Zuchelli, Hunter & Associates of Annapolis, Maryland.

After the decision was made to locate the new community college campus in the suburbs, Zuchelli was faced with recommending viable alternatives for downtown's future. There are several encouraging plan elements as evidenced by the illustrative sketch shown, as well as down-to-earth realism in the analysis of potential downtown markets for retail shops, offices, and housing. But the most welcome aspect of the plan is its endorsement of Main Street preservation as a major focus for that part of downtown.

Anticipating a new round of urban regeneration for downtown, the plan recommends continued vigilance in protecting district buildings and renewed efforts to reintegrate them into the economic life and emerging use patterns of the area. Zuchelli cites experiences from successful downtown renaissance efforts in other cities: Historic buildings can offer an environmental attraction which is virtually impossible to duplicate by contemporary development techniques, and the buildings are adaptable to a variety of uses.

The plan recognizes that some of the district's buildings may be beyond saving. And in these cases recommends that replacement, "infill" buildings be sensitively designed to maintain the scale and character of the street facade, with particular attention given to materials, window openings, building height, cornice treatment and storefront design.

From the historic State Capitols where the Constitution and its amendments were debated and ratified, to the schools where its principles have been taught, to the homes and workshops where families and businesses have flourished under its freedoms, physical reminders of our Constitution's history surround us.

# EDITOR'S RAMBLINGS What downtown can learn from suburbia

The City Commission has adopted a downtown action plan that includes a preservation element, sending an encouraging message to local preservationists. But paper plans will not bring about revitalized bricks and mortar without special attention to implementation.

Those interested in downtown must recognize that suburban shopping, office and residential complexes have a competitive advantage in that they are typically new developments under a unified management plan, which promises participants a defined part of an attractive whole.

Downtown must create similarly attractive environments to compete with the suburbs. But because there are many different property owners with divided interests, there is no shared management concept to address the suburban challenge.

Other cities have resolved this dilemma by use of zoning regulations that establish design guildelines and qualified review boards. Direction is provided for quality rehabilitation of old buildings and compatible design of new ones. Thereby a unified sense of place can result that would otherwise be impossible to achieve.

Serious consideration should be given to such a specially regulated district for Owensboro's Main Street.
